# Expé 138 Contest Rules Collaboration with the Manoir du Café and Tourisme Côte-Nord June 1 to July 1, 2024

This document mentions the rules of the 2024 Expé 138 contest. This contest is open to residents of Quebec. It is valid only for people within the territory of Quebec who can claim their prize in Quebec. This contest is a collaboration between Tourisme Côte-Nord and the Manoir du Café. A purchase is required to participate. The product that can contain a winning ticket, nicknamed *Ticket d'or* in the promotion, is the Expé 138 400g bag of coffee, ground or beans, which can be purchased online here (<a href="https://manoirducafe.com/collections/tous-les-cafes/products/expedition-138">https://manoirducafe.com/collections/tous-les-cafes/products/expedition-138</a>) or in one of the 30 points of sale mentioned on the interactive map on the competition page (<a href="https://www.tourismecote-nord.com/fr/concours/expe-138/">https://www.tourismecote-nord.com/fr/concours/expe-138/</a>). There are 25 winning tickets among 2,000 bags, distributed in more than 30 points of sale in Quebec. This gives a 1 in 80 chance of winning a prize. The contest is valid while supplies last.

At the same time, you could win 6 months of free coffee (6 kg of coffee, value of \$240) from the Manoir du Café by subscribing to the Manoir du Café and Tourisme Côte-Nord newsletter for free via the form on the contest page. The draw for the winner of the newsletter subscription is July 1, 2024. The data collected during the contest will be shared in full respect of confidentiality between Tourisme Côte-Nord and the Manoir du Café.

# 1. Prize Eligibility

In this document, the Association touristique régionale de la Côte-Nord (hereinafter referred to as "Tourisme Côte-Nord") and the Manoir du Café are the organizations responsible for the "Expé 138" contest. Employees of Tourisme Côte-Nord and Manoir du Café, partner companies, their promotional and advertising agencies, representatives, distributors (hereinafter collectively referred to as the "Promotional Parties"), as well as family and household members of the employees of each of the Promotional Parties are not eligible to enter the Contest.

# 2. Registration

This is a contest where **the participant must purchase a bag of coffee** to participate. The "Expé 138" contest begins on June 1, 2024 at 8:30 a.m. (Eastern Daylight Time) and ends on July 1, 2024 at 11:59 p.m. (Eastern Daylight Time). A participant can win 2 times, if he finds 2 winning tickets during several purchases.

Only one registration per participant per email address is allowed for the *Newsletter Subscription* component. By participating in the Contest, the User agrees to the terms of the Contest Rules stipulated herein.

# 3. Description and value of the prizes

#### 4. Draw

The draw for the entry will be conducted electronically on July 1, 2024 at 12 p.m. (Eastern Daylight Time), at the offices of the Manoir du Café, located in Baie-Comeau, Quebec. The winning entry will be drawn from all eligible entries received during the Newsletter Subscription Contest Period.

# 5. Price substitution

The prize must be accepted as awarded. No substitution of prizes is permitted, except at the sole discretion of Manoir du Café and Tourisme Côte-Nord. Le Manoir du Café reserves the right to substitute

the prize with another of equal or greater value. The prize is non-transferable, not redeemable for cash and cannot be credited in whole or in part.

# 6. Winner notification and awarding of the prize

**Prizes not claimed by a winner as of July 1, 2024 will be forfeited.** The names of the winners will be posted on the contest website, the Tourisme Côte-Nord website, the Manoir du Café website, as well as on social media (Facebook page, Twitter feed and Instagram account of Tourisme Côte-Nord and Manoir du Café), as required, from the date of confirmation of the winner's identity, and this, until the end of the promotional campaign. Consequently, the winner must consent to the publication of his/her name and city of residence on the websites of Tourisme Côte-Nord and Manoir du Café, in the form of " *The winner of Golden Ticket No 006 is: Annie B. from Lévis. Congratulations (...)* ".

#### 7. Conditions

By agreeing to participate in the Contest, the entrant agrees to sign a waiver of recourse form (hereinafter collectively referred to as the "Declaration and Waiver of Recourse Documents"), releasing Tourisme Côte-Nord and the Manoir du Café, promotional and advertising agencies, representatives, distributors, as well as their officers, directors, owners, partners, employees, consultants, agents, representatives, successors and assigns (hereinafter collectively referred to as the "Releasees") from any and all liability in connection with the Contest or the Prizes. A participant may request to unsubscribe from the newsletter at any time.
